## Definitions

### Trafficking in human beings

The UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, particularly Women and Children (the Palermo Protocol), supplementary to the United Nations Convention against Transnational Organized Crime, defines trafficking in human beings as follows:

*"Trafficking in persons shall mean the recruitment, transportation, transfer, harboring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation. Exploitation shall include, at a minimum, the exploitation of the prostitution of others or other forms of sexual exploitation, forced labor or services, slavery or practices similar to slavery, servitude or the removal of organs."*

Human trafficking may occur between different countries (cross-border trafficking) or within the same country between regions, between rural and urban areas, etc. (internal trafficking).

### Trafficking in Children

The definition of trafficking in children employed in the Palermo Protocol forms the core reference for the purpose of this research:

*"Trafficking in children shall mean the recruitment, transportation, transfer, harboring or receipt of a child for the purpose of exploitation. Exploitation shall include, at a minimum, the exploitation of the prostitution of others or other forms of sexual exploitation, forced labor or services, slavery or practices similar to slavery, servitude or the removal of organs."*

It is stressed that the trafficking of a child for exploitative purposes, whatever means are used, should be considered a crime.

### Child

"Child" means any person under the age of eighteen.

### **“Legal provisions” vs. social, procedural or other provisions”**

Questions on victim assistance in countries of origin and destination will ask for legal, social, procedural or other provisions on very specific aspects of victim assistance.

A first question will ask for “**legal provisions**” by which the legislation explicitly states that a child victim is entitled to a particular aspect of assistance (e.g. a risk assessment prior to repatriation). If you find a relevant provision in the legislation, you will tick the YES box. This will not imply any statement on implementation, however, if you have comments on how this legislation is implemented, please feel free to add them under “comments” to the same question.

Whether or not such legal provisions exist, there may also be other forms of provisions referred to as “**social, procedural, etc.**” providing that a particular aspect of assistance is in place. This may refer e.g. to social service regulations, local or regional practices, procedures established by tradition, implemented by communities or NGOs. As an example, it may be the case that even if there are no legal provisions to guarantee child victims access to education, existing shelters as a general rule may always provide access to education. Such information will be of interest to us.

For some elements of assistance, there can be only legal provisions (e.g. temporary residence). Hence, the questions on other provisions drop out.

<sup>1</sup> "Durable solution" refers to long-term arrangements for children victims of trafficking as opposed to short-term solutions (such as reflection period, emergency assistance and temporary residence permits). There are three general forms of durable solutions: local integration, return to country of origin or third country resettlement. Durable solutions can also be seen as prevention of re-trafficking.
